ORDINANCE: WATER & SEWER RATE INCREASE

The following ordinance was presented to the Board of Commissioners on second reading:

AN ORDINANCE AMENDING ORDINANCE NO. ~~98C-5~~ **07C-04** AND
CODE OF ORDINANCES CHAPTER 150 TO INCREASE CHARGES
FOR WATER SERVICES OF THE MAYSVILLE UTILITY COMMISSION

Summary

This Ordinance amends prior Ordinances and Code of Ordinances Sections 150.61 and 150.63 to increase all water service charges by 15%; to increase all sewer rates by 10%; to increase the residential deposit from \$75 to \$125; and to increase the service connection fee to \$900 for 1" service effective 1 June 2009. This increase is necessary to provide Maysville Utility Commission revenues for operation and maintenance expenses and for required updates to the system.

Motion by Commissioner Litton, second by Commissioner Mains to adopt the ordinance as presented on second reading. Upon call of the roll, voting is as follows: Voting aye: Commissioner Mains, Commissioner Litton, Commissioner Ashley, and Mayor Cartmell. Abstain: Commissioner Pfeffer. The motion adopted.
